- Notice is given to qualified persons residing within Box Elder County that the Presidential Preference Primary Election is to be held March 05, 2024 from 7:00 a.m.-8:00 p.m.
- Notice is given of the Early Voting times and locations.
- Notice is given as to the location of Voting Assistance Centers within Box Elder County.
- Notice is given of the sample ballot for the Presidential Preference Primary Election.
- Notice is given of the election audit required by the Lieutenant Governor's Election Policy. The Audit will be conducted during normal business hours in the County Courthouse 01 South Main Street #10, Brigham City, UT beginning Wednesday March 13, 2024 at 9:00 a.m. and continuing until completed. Anyone desiring to witness the audit is invited to attend.
- Notice is given that on Tuesday March 19, 2024 at 11:00 a.m. at the Box Elder County Courthouse, Commission Chambers, 01 South Main Brigham City, Utah the Box Elder County Board of Canvassers will meet to canvass the returns and declare the results of the election.

### QUALIFICATIONS TO VOTE

U.S. Citizen, resident of the State of Utah for over 30 days preceding election, 18 years of age by November 5, 2024, and registered to vote in Box Elder County.

**You must present a valid form of identification to the poll workers at the time you vote in a Voting Assistance Center.**
